## Terms & Conditions

1. Customer agrees to lease from Fit Flags International (FFI) Flags and or Banners itemized on QuoteSheet #(s) \_\_\_\_\_ now part of this Agreement. The lease Term shall be for 24 months beginning with the Initial Delivery Date of \_\_\_\_\_ and automatically renew s for the same term thereafter.
2. Customer agrees to pay FFI a one-time Special Order Fee of \$ \_\_\_\_\_ for those custom items and a total Monthly Lease Payment of \$ \_\_\_\_\_. The 1st month Lease Payment and the Special Order Fee are paid up-front with the signing of this Agreement. All Fees are itemized on QuoteSheet #(s) \_\_\_\_\_. Special Order Fees are non-refundable.
3. Customer agrees to pay the total Monthly Lease Payment by the 15th day of each month. A Late Payment Charge of 1 1/2% per/month will be added to all outstanding balances past 30 days. Any action taken by FFI to enforce payment will not be grounds for termination of this Agreement by the Customer.
4. Customer can cancel this Agreement after the 12th month with 30 days written notice. Customer agrees to notify FFI in writing any dissatisfaction with FFI's service or products. FFI shall have 3 business days to resolve any issues before any breach of this Agreement can be proclaimed by the Customer.
5. Customer agrees that with the exception of any Special Order Items, all Leased items remain the property of FFI and will be returned within 5 business days after the termination of this Agreement. If said items are not returned within that time frame the Customer will be charged the List Replacement Cost minus 20% for normal wear. Customer agrees to be responsible for any damages to item that would be considered inconsistent with normal use or wear.
6. Customer agrees to monthly exchanges of all Leased items to ensure that proper maintenance can be performed. Each month at a pre-determined day and time, all Leased items must detached from flag poles, mounts and ready for pick-up/exchanged for identical items. Customer may be charged a shipping fee for all items not ready for pick-up.
7. Customer agrees if any clause contained herein shall in whole or part be determined to be unenforceable or invalid, said clause will be considered to be deleted from this Agreement and the Agreement shall remain in full force and effect without said clause or part.
